## NOTICE ON REVISION OF DEMURRAGE & DETENTION TARIFF RATES

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

Please kindly be advised that changes have been made to the following demurrage and detention tariff. The new level will be applicable to/from **Singapore** across all trade lanes and services and will be valid till further notice.

**Inbound Demurrage free time**

- \* denotes - First 72 hours free from the time container is discharged from vessel. In the event exceeding stipulated free-time, demurrage shall be calculated retrospective from the date/time container is discharged from the vessel by 24-hour block.
- Demurrage excludes any terminal charges or store rent. Store rent to be applied per terminal's published tariff.
- Days, where mentioned refers excludes Saturdays, Sundays and Public Holidays declared by the Ministry of Manpower, Singapore.

All detention and demurrage payment shall be made at assigned depot before off-loading of empty containers.
