## Notice of Surcharge Update

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

In order to continuously provide a reliable service, ONE will implement a **Change of Booking Status Fee (CBS)**. Please be guided that booking cancellation fees will be applied when :-

1) Booking is rolled over/reduced by customers 10 or less calendar days prior to vessel ETD Singapore on the date of request.

2) For DG/OOG cargo, CBS will be applied regardless of if the application has received approval from the vessel operator.

2) The charge will be applied on per TEU basis as described in the table below.

The new level will be applicable **from Singapore** across all trade lanes and services and will be valid till further notice.
